MEMBERSHIP RULES AND REGULATIONS:

1. Members will be allowed three guests free of charge Sunday to Thursday, and two free guests Friday and Saturday. Mixed groups are essential.
2. Members are obliged to sign themselves and their guests in on arrival.
3. Members are solely responsible for the behaviour of their guests.
4. Additional guests may occasionally be accommodated on a guest list. Members must always call ahead to check availability.
5. Members are required to treat all staff and other members with courtesy and good manners. Failure to do so may result in membership being revoked.
6. Membership does not necessarily guarantee admission. Once capacity is reached members may be admitted on a one in one out basis.
7. Management always reserves the right of admission.
8. HEYJOCLUB does not employ a strict dress code, however, members are advised to exercise discretion with their attire.
9. Memberships are non transferable. If you are found to have lent your membership to a non-member, your membership will be immediately revoked.
10. Members are required to vacate the club upon request. Failure to do so may result in membership being revoked.
11. Members are requested to settle all bills before leaving the club, including guest's bills.
12. In order to aid efficiency of service, tables are requested to order drinks by the bottle.
13. Tables must be reserved in advance and will be allocated on a first come first served basis.
14. Tables will be held for thirty minutes from the time of booking. If you are delayed you may call ahead to see if this can be extended.
